<u>"I am Responsible</u>.

When anyone, anywhere, reaches out for help, I want the hand of A.A. always to be there.

And for that: I am responsible."

The Responsibility Statement was written for the 1965 A.A. International Convention in Toronto by Al S., a former AA trustee and *Grapevine* editor. Bill W. expanded on the theme in an essay called "Responsibility Is Our Theme" for the July 1965 *Grapevine*. It became a regular feature of the *Grapevine* shortly thereafter.

In 2005, A.A. members congregated in Toronto for the International Convention to celebrate the 70 years that brought A.A. from a bond between two sober alcoholics to a worldwide Fellowship of more than two million members. The theme was "I am Responsible," reprising the theme of A.A's 30th birthday celebration.

Group responsibility is the theme of **Tradition 5** which, in the long form, states -

"Each Alcoholics Anonymous group ought to be a spiritual entity having but one primary purpose—that of carrying its message to the alcoholic who still suffers."

Concept X: "Every service responsibility should be matched by an equal service authority, with the scope of such authority well defined." <> How do we understand and practice "authority" and "responsibility" as they relate to group conscience decisions by G.S.R.s, D.C.M.s and our area delegates?

Let us always try to be inclusive rather than exclusive; let us remember that each alcoholic among us is a member of A.A., so long as he or she so declares."

A misconception about Alcoholics Anonymous is that it is a religious organization. That an A.A. group is <u>not</u> connected with the church, school or government office where it happens to meet is important to keep in mind. A.A.'s pioneering members realized, from the beginning, that their sole purpose was to help people gain sobriety. They went to great lengths to ensure the broadest membership among all who suffer from alcoholism. A.A. is a Fellowship, a community of like-minded sufferers, who have found a way out of a hopeless condition.

We needed help. We reached out. We found sobriety, and some obstacles. Many of us began to discover that we could utilize the A.A. program without conforming to religious or spiritual concepts. With time, we came to recognize that we could stay sober and enjoy full membership in the Fellowship, regardless of our beliefs. Spiritual experience in A.A. is broad and varied.
